# 5.2 Faculty of Communications, Art and Technology

School for the Contemporary Arts

It was suggested to change course number from CA 822 to CA 830 to make the numbering chronological based on when a student would take the course in their program. S. Poyntz informed the committee that course numbers at the department of Contemporary Arts are commonly listed by the field or area and they do not necessarily follow chronological order. Concern was raised regarding students producing essays and prematurely submitting them for publication in journals in CA 822. S. Poyntz confirmed that the students get encouraged to submit work for publication; although this kind of work places burden on peer reviewed structures and editorial boards, the benefits gained by students are much greater than the drawbacks.

A question was raised whether this certificate will be advertised and direct admissions will be allowed. SGSC was informed that this was not the purpose of the certificate. Approval of this certificate will also help to reduce the number of admission exceptions requested by the Faculty.

School of Resource and Environmental Management

Concern was raised that the large discrepancy in the number of units between the thesis and project streams might create confusion and wrong expectations among the prospective students. It was either recommended to decrease the difference in units or a more detail description needs to be added to inform the students of the workload in both streams.

**Note:** DGS did a review of programs with multiple streams and confirmed that the MA in Gerontology has a similar unit differential, which the department has confirmed has not created major problems for their students or confusion. Consequently, it was recommended to add a more detailed description in REM's program description to clarify expectations for the students. The following sentence was added in the Program Requirements: "The thesis stream is more research intensive, producing a final thesis document that is larger in scope than a project and that makes a distinct original contribution to knowledge."
